

**ELASTRON KİMYA SANAYİ VE TİCARET A.Ş.**  
**INFORMATION APPLICATION FORM**

At Elastron Kimya Sanayi ve Ticaret A.Ş. (“Elastron”), the protection of privacy of private life; ensuring and protection of information security and respect to ethical values and in particular, the protection of fundamental rights and freedoms are among our primary principles. The data subjects are granted with the right to make certain requests under Article 11 of the Law on the Protection of Personal Data No. 6698 (the “LPPD”) LPPD regarding the processing of personal data. As the Data Controller, Our Company has prepared this information application form in order to ensure the exercise of such rights by Data Subjects, and to fulfill the obligation to inform, as stipulated under article 10 of the LPPD.

Pursuant to article 11 of the LPPD, you may exercise your rights which are listed below by applying to Elastron and filling in the form attached hereto:

- a) to learn whether the personal data relating to you are being processed or not;
- b) if they are processed, to request information with regard to processing;
- c) to learn the purposes for the processing of personal data and whether they are used for such purpose or not;
- d) to know the third persons within or outside the country to whom the personal data are transferred;
- e) to request the rectification of the personal data if your personal data are processed incompletely or inaccurately;
- f) to request deletion or destruction of the personal data under the conditions laid down in Article 7 of the Data Protection Law;
- g) to request the notification of third persons to whom the personal data are transferred, about the processes carried out within the scope of sub-clauses (d) and (e);
- h) to object to the processing, exclusively by automatic means, of your personal data, which leads to an unfavorable consequence for you;
- i) to claim compensation if you suffered damage due to unlawful processing of your personal data.

Pursuant to article 13 of the LPPD, data subjects should submit their requests to our Company in writing, or in other ways as will be determined by the Personal Data Protection Board (the “Board”). Within this scope, the applications to be made to our Company can be sent to us, free of charge, by printing out this form after filling it in and by selecting one of the four methods below.

Third parties cannot make exercise the right to information which is regulated in art. 11 of the LPPD on behalf of data subjects. In order for a person other than the data subject to be able to make a request, an originally signed and notarized copy of the special power of attorney which is issued on the relevant matter in the name of the person who will file the application should be submitted.

In case the operation requested by the Data Subject requires an additional cost, our Company will charge the fee in the tariff designated by the Board.

Pursuant to art. 13(2) of the LPPD, your applications which are communicated to our party will be concluded, depending on the nature of the request, within thirty days as of the receipt by our Company. Our responses will be delivered to you in writing or electronically, as per art. 13 of the LPPD.
